6. Highworth Town Council reserves

- IJ has looked at HTC accounts to end 31/3/16. £455k in hand, £303 allocated and £152k unallocated which is 45 % of precept. David Lane responded that unallocated was down to excellent budgeting over 23 years, some expenditure due this year from reserves, no policy in place on how money is to be used. IJ Yes a reserve is necessary, but too excessive, feels past tax payers have been overcharged. What are HCPG's views?

- NG accrued overtime and funds in a comfortable place
- There should be a policy on unallocated funds and what they would spend it on. What is a good reserve?
- Accounts are available monthly to councillors
