### 5. Tourism – Update and action:

Improving and enhancing the Visitor Experience

- 1. Open a tourist information office, Lighthouse Bookshops deemed to be but only leaflets. We want to give correct information, active visitor experience
- 2. Museum
- 3. Space could sell things Highworth
  - Website Visit Wiltshire funded by HTC. Tourism is Policy 4 of Neighbourhood Plan. SBC Local Plan RA1
  - Visited Lloyds Bank 3 times, ideal venue. Owner likes the idea of a visitor centre.
  - Historical thinking's with Historical Society
  - Contacted Plunkett Foundation. Mission: Inspire rural communities, help and encourage communities to do but provide tools to do it. 2 days free time ends 15/11
  - Started a Business Plan 3-year cash flow statement done, conclusion that it's a viable proposition. Some assumptions are optimistic
  - 200 members contribute £10 pm as shares
  - 0% business rates, £12k rent pa (hopefully HTC will repay rent) negotiable
  - Expenditure £10 ph. x 35 hours a week Office Manager and volunteers
  - Robin Clegg concern over footfall, could be low. Why should shareholders/HTC put money in to it?
  - Space needed for shop, display and museum
  - Improving/promoting Highworth

- What will attract coaches? Toilets, close to M4, parking
- (make our own money Mabel Stranks)
- Persuade Highworth it's a good idea
- Community Benefit Society Industry/trade for the community. Sell shares to the resdients, unlikely to be a dividend, a gift/loan. Any profit reinvested in Company. Safe and supported by Plunkett (£140) 1 member = 1 vote
